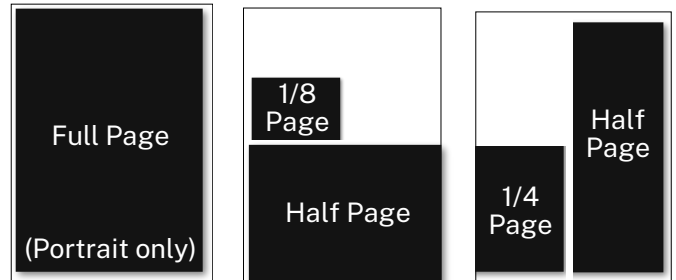
PDF files:
